According to the official document (No.1090038993) issued on MAR-13, 2020 by Ministry of Education, Taiwan, students should carefully assess the local situation of COVID-19 and the risks of taking flights, and are suggested to avoid going abroad for unnecessary activities with the outbreak of COVID-19 globally.

Furthermore, according to the command made by NCU Anti-Epidemic Committee held on MAR-17, 2020, all NCU students should refrain from going abroad for unnecessary activities, which takes effect immediately until JUNE-15, 2020. If you still plan to go abroad due to personal plan, you need to sign the affidavit and get permission from NCU before going abroad:

(1) Before Going Abroad

I firmly understand the current situation of COVID-19 epidemic of the country I'm going to, and I still need to go due to my personal plan.

(2) While Abroad

I firmly understand if I am affected by COVID-19, I will pay for all medical bills by myself. I will not ask for any compensation from NCU.

(3) After coming back to Taiwan

I firmly understand after coming back to Taiwan, I need to follow the related quarantine measures announced by the Central Epidemic Command Center (CECC), Taiwan. I will complete all above measures before going back to NCU to continue my study.

By signing below, I agree with above statements. Violation of any statements mentioned above, I, myself and my guarantor will undertake all legal liability and will release National Central University from all liability, costs and damages which could arise from my going abroad.
